

EMERGENCY RESPONSE
GAS or DIESEL SPILLS, FIRE, and FLOODING

FUEL SPILLS: CONTAIN ♦ ABSORB ♦ PICK UP

CONTAIN THE SPILL

1. **Contain** the spill with Speedi Dri located in the backroom. Apply Speedi Dri starting with the area furthest from the source, to **absorb** the product.
If fuel is still leaking or there is any danger of fuel igniting,
 - a. Shut off the pumps with emergency shut off button.
 - b. Have fire extinguisher (located by the front door) ready to use.
2. Barricade off the area; do not allow the product to get into a storm drain, river, etc.
3. Bag the nozzle until fixed or deemed safe by a technician.
4. Estimate the amount of gasoline spilled. **It must be reported to the State IF the spill is**
 - A. **25 gallons or more, OR**
 - B. **less than 25 gallons but is NOT contained, or if there is an impact on ground or surface water.****NH Hazardous Material Office: 1-603-271-3899 8 am to 4 pm M-F OR 1-603-223-4381**
Record the time and date you called and to whom you spoke. If the spill is reported to the State, you must contact Dave McQuade immediately at 802-373-5958.

5. **Pick up** the Speedi Dri and place in a double plastic grocery bag (for smaller amounts) or a double garbage bag (20 lb max fill) for larger amounts. Place bagged Speedi Dri in or near the 5 gal bucket with lid at your store's designated hazardous waste area.

ACCIDENTS: Call the Police. Fill out an accident report (copies on our website). Get all the relevant information: insurance name, policy #, phone #, license plates, pictures, and names, addresses and phone numbers of witnesses, all people in vehicles, and the police officer. Obtain written statements from witnesses.

Complete an accident form and/or spill form as soon as the emergency has been resolved.

Other Areas of Precaution:

1. No smoking.
2. Wear a proper, brightly colored street garment if you need to work in the road.
3. If instructed to evacuate, lock up building and turn off pumps. Evacuation Route: Exit building through main door and depart property in direction of least traffic. Alternate Evacuation Route: Exit building through a window or other door if available, and depart property as best able.
